BARGAINING UPDATE #19 – September 28, 2022

Your Union will be conducting a ratification vote of the Red Chris USW Local 1-1937 members, as requested by the BC Labour Relations Board (BCLRB). Prior to the vote, the Local Union will be conducting two virtual meetings via Zoom that will allow members to hear directly and ask questions from the Local Union and its bargaining committee on the details of the recommended terms of settlement proposed by the BC Labour Relations Board.

Ratification Vote

The ratification vote will take place electronically via Survey Monkey. Members will either receive an email or a text message (not both) which once received will allow members to vote on the following question: Are you in favour of the mediators recommended terms of settlement for your collective agreement. YES or NO

Voting will commence on October 12th at Noon (Pacific) until October 26th at Noon (Pacific) when voting will close.

The Union will then notify the BC Labour Relations Board of the vote results on October 27th.
