### Coastal BC Forest Industry Survey & Contract Resolution Process

On behalf of the Local Union's 2024 Coast Bargaining Committee, I hope that all of our members are doing well as we enter the fall from a long hot summer. Time has passed very quickly it seems, as our five (5) year Collective Agreement for the Coastal BC Forest Industry is due to be renegotiated next year.

With industry negotiations on top of mind for the Local Union, preparations have begun to ensure we determine what our members see as priorities for the bargaining table next year. Those determinations will be finalized on February 22, 2024, when the Local Union holds its Delegated Wage & Contract Conference.

## **Member Survey**

The Local Union will start by polling our members using Survey Monkey. The Survey will ask members to prioritize bargaining issues they see from the lowest priority to the highest priority. This will give your Bargaining Committee a general guide to what our members would like us to improve upon in their Collective Agreement.

The Survey will be sent to members on October 12, 2023, via Mass Text and Email. The poll will be closed on October 27, 2023.

If you have recently changed your cell phone number or email address, please email or call your Local Union office in Duncan, Port Alberni, Courtenay, Port McNeil, or Burnaby. We want to ensure as many members as possible receive the Survey and bargaining updates that will follow.

#### **Submitting Contract Resolutions**

Once the polling is complete, members in the primary forest industry will have the opportunity to put forward their ideas for collective bargaining by filling out contract resolutions for the Local Union in your Operations or at Area Resolution Meetings. This will be done in one of two ways:

1. Putting your idea forward in writing to your operations Plant/Camp Committee (Ask for resolution forms from a Committee representative or Local Union office or download them from our Website at <a href="www.usw1-1937.ca">www.usw1-1937.ca</a> under the Resources tab, then Forms tab, then click on USW Forest Industry Bargaining Resolution Forms; or
